- 9. Loss to Buyer's Property. Buyer may not cancel or modify, including but not limited to movement of delivery dates for the Products, any order for any reason except with Seller's written consent and upon terms that will indemnify, defend and hold Seller harmless against all direct, incidental and consequential loss or damage and any additional expense. Seller, at any time, may change features, specifications, designs and availability of Products.
- 15. Assignment. Buyer may not assign its rights or obligations without the prior written consent of Seller.

- 17. Waiver and Severability.
