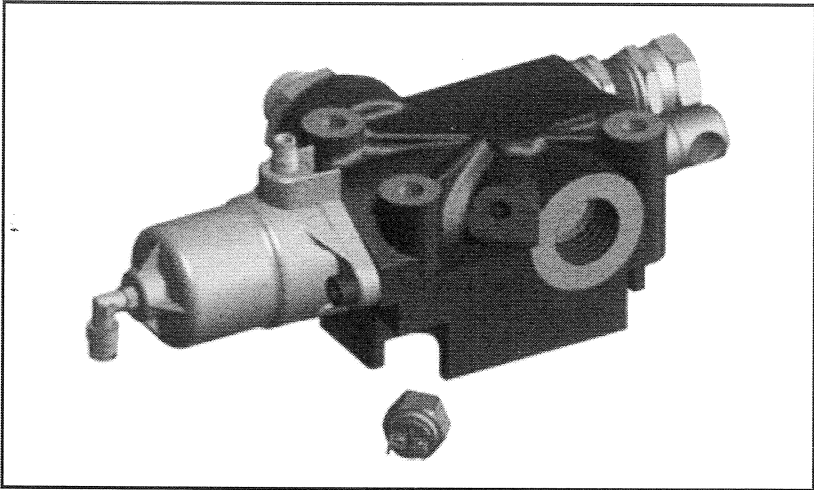

- Rotating auxiliary driveshafts are dangerous. You can snag clothes, skin, hair, hands, etc. This can cause serious injury or death.
- Do not go under the vehicle when the engine is running.
- Do not work on or near an exposed shaft when the engine is running.
- Shut off the engine before working on the Power Take-Off or driven equipment.
- Exposed rotating driveshafts must be guarded.

Guarding Auxiliary Driveshafts

WARNING: We strongly recommend that a Power Take-Off and a directly mounted pump be used to eliminate the auxiliary driveshaft whenever possible. If an auxiliary driveshaft is used and remains exposed after installation, it is the responsibility of the vehicle designer and P.T.O. installer to install a guard.

Using Set Screws

WARNING: Auxiliary driveshafts may be installed with either recessed or protruding set screws. If you choose a square head set screw, you should be aware that it will protrude above the hub of the yoke and may be a point where clothes, skin, hair, hands, etc. could be snagged. A socket head set screw, which may not protrude above the hub of the yoke, does not permit the same amount of torquing as does a square head set screw. Also, a square head set screw, if used with a lock wire, will prevent loosening of the screw caused by vibration. Regardless of the choice made with respect to a set screw, an exposed rotating auxiliary driveshaft must be guarded.

Important: Safety Information and Owner's Manual

Chelsea Power Take-Offs are packaged with safety information decals, instructions, and an owner's manual. These items are located in the envelope with the P.T.O. mounting gaskets. Also, safety information and installation instructions are packaged with some individual parts and kits. **Be sure to read the owner's manual before installing or operating the P.T.O.** Always install the safety information decals according to the instructions provided. Place the owner's manual in the vehicle glove compartment.

**WARNING: Operating the P.T.O. with the Vehicle in Motion**

Some Power Take-Offs may be operated when the vehicle is in motion. To do so, the P.T.O. must have been properly selected to operate at highway speeds and correctly matched to the vehicle transmission and the requirements of the driven equipment.

If in doubt about the P.T.O. specifications and capabilities, avoid operating the P.T.O. when the vehicle is in motion. Improper application and/or operation can cause serious personal injury or premature failure of the vehicle, the driven equipment, and/or the P.T.O.

Always remember to disengage the P.T.O. when the driven equipment is not in operation.

⚠ NEVER run your hand, arm or any other part of the body over a hydraulic hose, line, fitting or assembly to check for leaks. A pinhole leak can release toxic fluid at more than 600 feet per second – acting as a hypodermic needle penetrating both protective clothing and skin at short distances. A seemingly superficial wound could lead to loss of life or limb as a result of fluid poisoning.

NEVER loosen or tighten a hydraulic connection when the system is under pressure. The connection could fail catastrophically and cause an injection injury and/or damage to property. Be sure that all high pressure is bled/ released from the hydraulic system.

When working with hydraulic hose, lines, fittings or assemblies - whether during installation, preventive maintenance, or scheduled component replacement, exercise extreme caution. Fluids under high pressure can be dangerous and potentially lethal. Make sure all high pressure is relieved so that hoses and components may be examined safely.

CVA16DP Valve Overview

The Parker Control Valve Assembly is a dual pressure relief setting system used in combination with wetline kits. The system allows the operator to use his truck for dual functions by switching between different operating pressure requirements.

The operator may connect to a dump trailer operating at 2000 psi. and later connect to a different systems similar to a Moving Floor trailer requiring 3000 psi. without making any pressure adjustments.

The operator has one pressure hose to connect to the trailer eliminating the need to remember to switch between low and high pressure, making for a safer operation.

Installation of the Parker CVA16DP Control Valve

Assembly with dual pressure setting relief on the truck frame can be mounted in any orientation. However, it should be rigidly mounted using proper mounting hardware. Recommended mounting would be between the truck's frame rails to protect the valve from road debris kicked up by the tires (see Fig 1).

There are three (3) hydraulic hoses, two air lines to connect.

1. See SK-506 on page 7 for proper hydraulic hose and air connections
2. All hydraulic fittings should be torque to their proper specifications before using the hydraulic circuit.

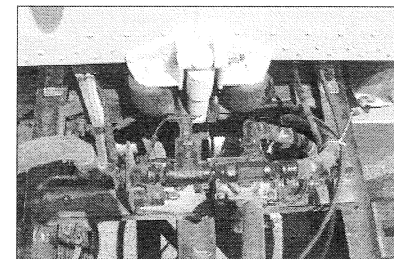

JIC 37° and S.A.E. 45° Flare

Parker's recommended assembly method for JIC 37° flare and SAE 45° flare is the Flats From Wrench Resistance (FFWR) method. This includes steel as well as other materials.

The torque values assigned by size are for reference only and are only applicable to Parker system components using the FFWR method with trivalent chromate passivation on zinc plating of carbon steel components without lubrication.

Torque Conversion

The torque values for other materials are as follows:

- Brass fittings and adapters - 65% of the torque value for steel.
- Stainless steel, and Monel - Use 5% higher than listed for steel. Threads to be lubricated for these materials.
- Dissimilar metals - use torque value designated for the lower of the two metals.
- All fittings are dry except as noted above. The Flats From Wrench Resistance (FFWR) and torque values listed above are consistent with the values recommended by Parker Tube Fittings Division (614) 279-7070 or www.parker.com/tfd.

Operation of CVA16DP Valve

Control valve number CVA16DP is used to provide pump flow to the trailer. More importantly it allows from within the vehicle cab two different pressures. Alternative higher pressures are achieved by engaging the auxiliary air valve (high pressure) in the cab. **Use of the auxiliary air valve (high pressure) on trailers designed for only the low pressure could result in equipment damage.**

NOTE: Valve comes factory pre-set at 2100 psi for low pressure and 3000 psi for high.

Dump Trailer

Parker Combo Valve AVCP-695-M-T-8
OEM PTO Switch Installed

1. Connect the tractor to the trailer using a male and female quick coupler. (Figure 1)
2. For hose connections to the CVA16DP valve see (Figure 2)
3. Turn the PTO switch on and use the Combo valve AVCP-695-M-T-8 to control the CVA16DP valve using the lever control to raise, hold, or lower the dump trailer. (Figure 3)
4. After fully lowering the bed use the PTO switch provided by the OEM to shut off the PTO and disable the hydraulic system.

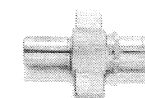

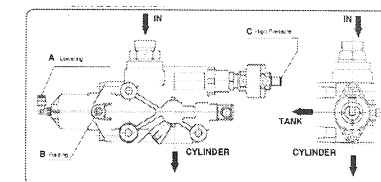

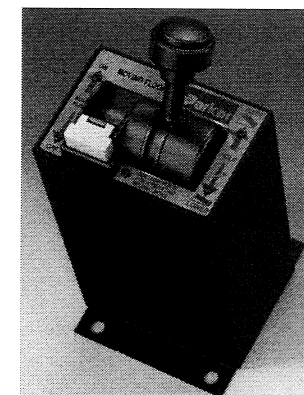

Moving Floor and 2 Line Trailer Applications Parker Combo Valve AVCP-695-M-T-8 OEM PTO Switch Installed

1. Quick Couple the High Pressure Hose From the tractor to the trailer. (Figure 1)
2. Quick Couple the Return Line hose from the trailer to the tractor. (Figure 1)
3. To start the moving floor
 - A. Turn the PTO on
 - B. Turn the moving floor switch to the on position this will set the moving floor to the high pressure mode. (Figure 2)
 - C. shift the hoist control to the raise position this will enable the moving floor controls (Figure 2)
4. Use controls on the trailer for moving floor
5. To STOP moving floor operations move hoist lever back to "HOLD". Turn the Moving Floor Switch to the off position and then Turn the PTO switch off.

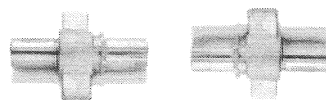

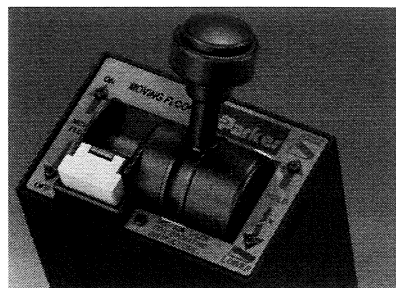

Dump Trailer Moving Floor and Two Line Trailer Applications Parker Combo Valve AVCP-295-MTCK8 No OEM PTO Switch Installed

Dump Trailer

1. Quick Couple Tractor to the Trailer. (Figure 1)
2. For hose connections to the CVA16DP valve see (Figure 2)
3. Turn the PTO switch on and use the Combo Valve AVCP-695-M-T-8 to control the CVA16DP valve using the lever control to raise, hold, or lower the dump trailer (Figure 4)
4. After fully lowering the bed place the Combo valve in the hold position, and turn the PTO off.

NOTE: Never turn the Moving Floor switch to the on position when operating a Dump Trailer Hoist. Flipping this switch while operating a Hoist can cause serious injury and or death to the driver.

Moving Floor and Two Line Trailer Applications

1. Quick Couple the high pressure hose from the tractor to the trailer (Figure 3)
2. Quick Couple the the return line hose from the trailer to the tractor (Figure e)
3. To start the moving floor
 - a. Turn the PTO On
 - b. Pull the moving floor button to the on position this will set the moving floor to the high pressure mode (Figure 4)
 - c. Shift the hoist control to the raise position this will enable the moving floor controls on the trailer. (Figure 4)
4. Use the trailer to operate controls
5. To stop moving floor operations move hoist lever back to HOLD, and push moving floor button to the off position. Turn PTO switch off.

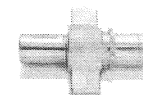

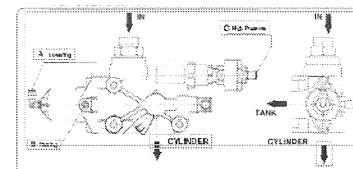

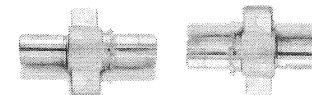

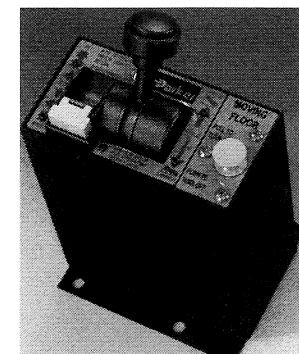

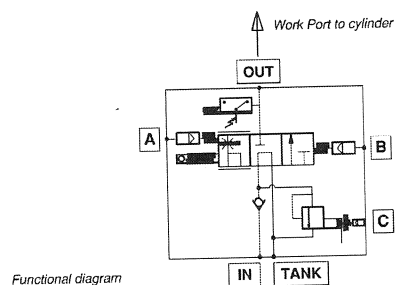
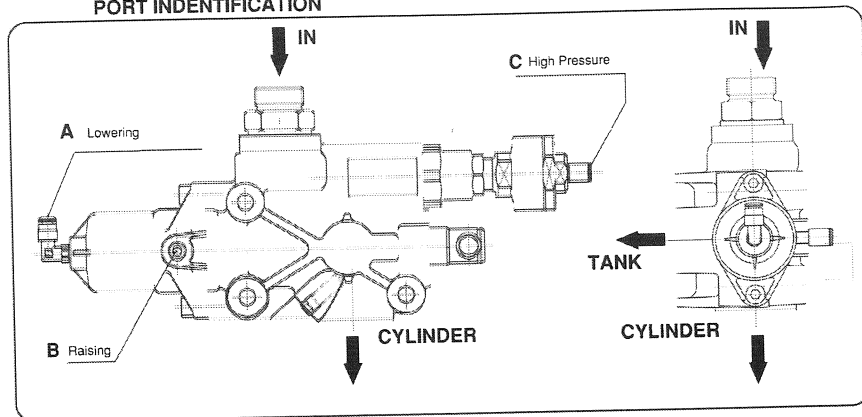
Installation Sketch

CVA16DP Relief Valve 2 Independent Pressure Relief Valve Setting Instructions

The double pressure pneumatic relief valve allows the setting of the higher pressure level independently from the low pressure value. Disconnect equipment attached to the cylinder port. Install a pressure gauge, with a pressure range to cover 0-400 bar / 0-5800 PSI, to the cylinder port. When setting the high pressure relief valve, apply air pressure to the top of the relief valve.

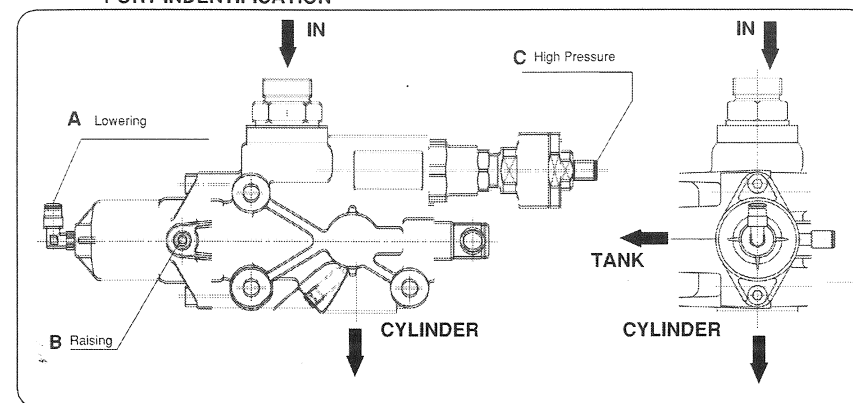
Pressure setting Range approx:

Low pressure: 0-200 bar / (0-2900 PSI)

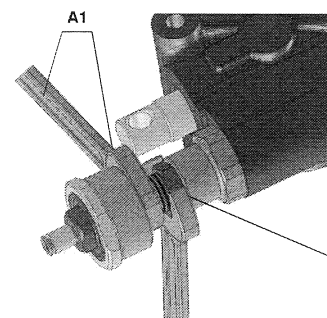
High pressure: low pressure value + 0-200 bar / (0-2900 PSI)

Caution total maximum pressure could be set to 400 bar / (5800 PSI)

LOW PRESSURE SETTING

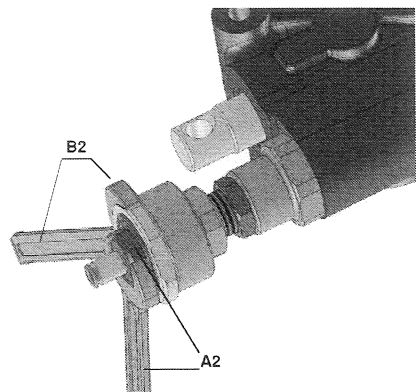


- 1) Unscrew the nut **B1** while maintaining position of tool/nut **A1**.
- 2) **Rotating (CW)** tool/nut **A1** the pressure increases.
Rotating (CCW) the pressure decreases.
Check the pressure with a pressure gauge.
- 3) Lock the nut **B1**, while maintaining position of tool/nut **A1**.

Relief Valve 2 Independent Pressure HIGH PRESSURE SETTING

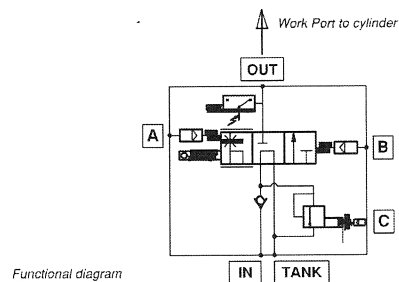


- 1) Unscrew the nut **B2** while maintaining position of nut **A2**.
- 2) **Rotating (CW)** tool/nut **A2** the pressure increases.
Rotating (CCW) the pressure decreases.
Check the pressure with a pressure gauge installed at the cylinder port.
- 3) Lock the nut **B2** but keeping carefully attention to maintain tool/nut **A2** position.

WARNING: any setting or adjustment of relief valve has to be carried out by using proper pressure gauges in the hydraulic circuit and should only be done by a **qualified hydraulic technician**

- If the Low and High pressure are set at their highest level possible, the High pressure can go over 400 bar / (5800 PSI).
- Changes applied to the Low pressure affect also the High pressure level.

In case you need to change **ONLY** the Low pressure setting you have to adjust the High pressure value in order to restore its initial value.

Power Take-Off Maintenance

Due to the normal and sometimes severe torsional vibrations that Power Take-Off units experience, operators should follow a set maintenance schedule for inspections. Failure to service loose bolts or Power Take-Off leaks could result in potential auxiliary Power Take-Off or transmission damage.

Periodic P.T.O. MAINTENANCE is required by the owner/operator to ensure proper, safe and trouble free operation.

Daily: Check all air, hydraulic and working mechanisms before operating P.T.O. Perform maintenance as required.

Monthly: Inspect for possible leaks and tighten all air, hydraulic and mounting hardware, if necessary. Torque all bolts, nuts, etc. to Chelsea specifications. Ensure that splines are properly lubricated, if applicable. Perform maintenance as required.

With regards to the direct mounted pump splines, the P.T.O. requires the application of a specially formulated anti-fretting, high pressure, high temperature grease. The addition of the grease has been proven to reduce the effects of the torsional vibrations, which result in fretting corrosion on the P.T.O. internal splines as well as the pump external splines. Fretting corrosion appears as a "rusting and wearing" of the pump shaft splines. Severe duty applications, which require long P.T.O. running times and high torque may require more frequent regreasing. Applications such as Utility Trucks that run continuously and are lightly loaded also require frequent regreasing due to the sheer hours of running time. It is important to note that service intervals will vary for each and every application and is the responsibility of the end user of the product. Chelsea also recommends that you consult your pump owner's manuals and technical services for their maintenance guidelines. Fretting corrosion is caused by many factors and without proper maintenance; the anti-fretting grease can only reduce its effects on components.

Chelsea offers the grease to our customers in two packages. The first is a 5/8 fluid ounce tube (379688), which is included with every applicable P.T.O., and the second is a 14-ounce grease cartridge (379831).
